Extensive remodeling of interior spaces and the building's exterior are currently underway. The main entrance of the building will move to the northeast corner of the building across from Esther Short Park. Enhanced landscaping, including a water feature, and additional parking will be added to the site. The 33,300 square foot building will include an 875 square foot community room with seating capacity for 60 people and an adjacent, partially covered patio. More exciting details regarding the usage of the community room to come. We look forward to serving you in our new office.
