

SELF's story began in August 2001 when six of the founding members asked the question, "How can we work to improve opportunities for our community infants, toddlers and preschoolers?" Research shows that quality early learning can make a big difference, especially for disadvantaged children by closing the opportunity gaps that start before kindergarten. Unfortunately, when children start behind, they often stay behind, and low-income children are most at risk of struggling in the early years. By the third grade, 40 percent of low-income students read below grade level, compared to 27 percent of students overall.
