Walk & Knock

The first Saturday of December is an exciting day for our community because of Walk & Knock. This is one the nation's largest one day food drives that solicits charitable donations of food, supplies and money. The donations are then given to the Clark County Food Bank and provide food to those in need across our

How does it work?

Walk & Knock distributes grocery bags throughout the county the week before the food drive. Local residents will then fill the



bags with food and place the bags on their door steps.

Volunteers go door-to-door and collect the bags. The collected bags are delivered to one of the 10 drop-off locations or staging areas located throughout Clark County.

The food is then boxed by volunteers and delivered to the Clark County Food Bank.

From there it is distributed to 15 local food pantries and given to members in our community who need food during this busy holiday season.


