Options 360: February Referral Rewards Partner



During the month of February we are excited to partner with Options 360, an organization that is striving to positively impact our community and the people who live here. This non-profit organization serves women and teens who find themselves facing an unplanned pregnancy. They are an accredited medical clinic that provides caring, knowledgeable and non-judgmental services. Options 360 offers free services to every woman regardless of age, income, race or religion. Each woman who visits their office will receive information and support to make the best decision about her pregnancy. They believe individuals should be fully informed of all their options before making any decisions.

Options 360 serves the women who come into their clinic in a few different ways. First, they offer pregnancy testing. Pregnancy symptoms vary from woman to woman and pregnancy to pregnancy—offering pregnancy testing provides women with accurate information. A limited ultrasound exam is provided to confirm the pregnancy and how far along the woman is. The sex of the baby is not identified in these ultrasounds. If a woman makes the decision to abort, help and assistance will be provided through Options 360. Lastly, help and assistance will be provided to a woman throughout the pregnancy and beyond should the woman choose to carry the baby to term.

Options 360 has two locations in the Clark County Area—a Battle Ground Clinic and I-205 Clinic. Woman can make an appointment on their website options360.org/appointments.

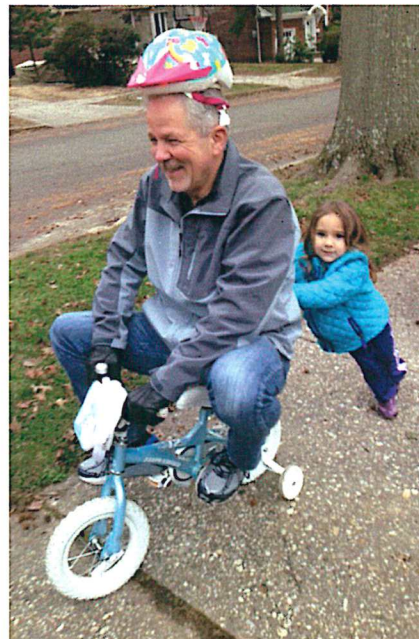

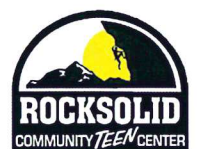
